Tim Robbins, Public Works Director joined the meeting to discuss new procedures for the Sculpture Trail this year which included safety precautions all involved would follow, time restrictions in Home Square during lunch, and Public Works staff to work with an Engineering firm to decide sculpture locations.

Ms. Holland stated Art Consultant Jim Davis emailed her the art sculpture entries, 61 entries were received. She stated the Sculpture Trail Selection Committee was scheduled to meet today at 2:00 p.m. at Town Hall but due to the inclement weather, the meeting was cancelled. She reached out to all members of the committee and asked them to email her their top 25 selections. The selection committee included: Corie Miller, Parks and Rec. Shared was the PowerPoint showcasing all the submitted entries. As each sculpture was displayed, the number of votes it received—if any—from the Sculpture Trail Committee was noted for consideration. The board narrowed the selections to their top 25, which would be submitted to the Public Works Director to coordinate with the engineering firm on potential locations. The final selection will be reduced to 12 sculptures.
