4 OLD BUSINESS

- a) Sculpture Trail Update
Presenter: Dane Martin

Chair Martin and Ms. Holland provided a recap of the installation for the new sculptures. It was stated this was a smooth process for all with great feedback already from several artists. There was discussion on the brochures for the Sculpture Trail, it was suggested to leave it the same size as it was last year. Ms. Holland would be scheduling a debrief meeting with those involved to receive input on what went well and things that could be improved on. There

was discussion on forming a sub-committee to create the Call For Artists for next year's trail.

- b) Call To Yarn Project Update
Presenter: Tammy Murray

Moving forward, this project would be called Field of Flowers. It was stated the anticipated reveal of this project would be April of next year. Board Member Murray stated kits would be made that would include a skein of yarn and instructions. Dates were proposed and volunteers were lined up to assemble these bags.

5 NEW BUSINESS

- a) Adult Art Exhibit
Presenter: Tammy Murray

Moving forward, this project would be called Emerging Art Exhibit and would be an exhibit for those that have never exhibited or sold an art piece. There was discussion on locations to hang the finished pieces, how to hang them, and how long they should be displayed. Board Member White suggested using a facility at Lionsgate or at the Civitan, he stated he would look into those options.

There was discussion about forming a sub-committee for this project. It was suggested to involve multiple businesses and potentially turn it into an art walk that coincides with the Last Friday event. Board Member Stambaugh offered to explore the possibility of merging it with Last Friday and agreed to take the lead on the Call for Artists portion of the project. She noted that an outline or a fully developed concept would be helpful to present to downtown business owners. She asked board members to let her know if they were interested in serving on the sub-committee. It was also suggested that the board introduce the idea to the public to gauge interest and community support before moving forward.

- b) Gingerbread and Jack o'Lantern Exhibit

Board Member Murray stated she would ask around the community to see if anyone remembered the Gingerbread Exhibit. The target would be to host this event this year.

There was discussion on hosting a Jack o'Lantern exhibit this fall in Horne Square. Board Member Murray stated she would take the lead on this.

There would be more discussion on both projects at the next meeting.
