3 OLD BUSINESS

- a) Knit Garden Project
- Presenter:* Tammy Murray and Tamara Smallwood

Ms. Murray stated Ms. Smallwood has taken this project and ran with it. Shared were samples that were created. There was discussion on having three different sizes and how many petals should go on each size flower, as well as pricing.

There was further discussion on the different material options to attach the flowers to and how to install them in the ground. It was stated once the frames are complete, we could connect with the crochet community to ask for any help.

The three locations for these flowers that Town management had suggested were the library, Town square, and Horne Square.

b) Little Free Library Update
Presenter: Joe Slaton

Mr. Slaton stated the library and post has been built. It needs to be painted and then it should be ready to be installed. He suggested painting it with milk paint which contains limestone; because of the limestone, the more it is exposed to the weather, the harder it gets. This paint is weather resistant. The post is made out of western cedar which is also weather resistant. He stated he put bookbag hinges on both sides of the library.

The idea of having children paint this at the Tree Lighting event was brought back up and it decided it was not the most ideal night. It was consensus of the board to have Mr. Slaton paint it the library.

There was board discussion on the type of books to have in the library, children and/or adult, and whether or not to take donations from the community. It was stated the library could hold approximately 30 15" books. Ms. Holland asked Mr. Slaton to let her know when the library is painted, and she would coordinate with Dale Matthews on an installation date at Clayton Area Ministries.

c) Mural Application Process

There was discussion on the current mural process. It was stated that there has been feedback in the community that citizens do not want to have murals on their buildings because they do not want to go through the process. It was stated that the Town of Garner does not have a mural process. Mr. Martin asked all board members to look through the current process and bring back any feedback at the next meeting. Citizen and muralist Adriana Ameigh was present at the meeting and shared her experience with murals for the City of Raleigh. She stated she would be happy to take a look at our process and provide feedback.

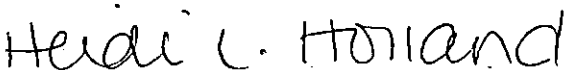
