Ms. Perricone discussed the new budget. The budget has been increased by \$5,000. It was stated approximately \$35,000 goes towards the Sculpture Trail.

There was discussion on the Little Library project. Ms. Murray stated she spoke with staff at the Community Center, and it was shared a lot of vandalism comes along with these book libraries. There was discussion on the best location for this library. It was mentioned to install at the Clayton Area Ministry. Ms. Perricone stated she would contact Dale Matthews with Clayton Area Ministry to discuss the possibility of putting the Little Library at their location.

Ms. Perricone stated when Joy Garretson, the Town's previous Library Director was here, she discussed having a mural on the wall of the library that faces Main Street. Shared was an example of a possible mural for this location. Ms. Perricone asked Council Member Casey how to determine if this would be possible. He stated he would draft a proposal and present it to Town Manager Cappola for review.

Council Member Casey requested that the tree sweater (Knit Bomb) project be brought back again this year. Ms. Murray shared a similar project where citizens knitted flowers to create decorative flower gardens around town, with the large petals supported by wire frames. While this project would be different, it would still encourage community participation. She suggested that citizens could pick up a crochet pattern this winter and have the flowers ready for display in the spring.

There was discussion on having painted benches throughout the Town. Shared were other project ideas such as more art on the Greenway, tunnel mural, crosswalk art, and the painted snake rock project.

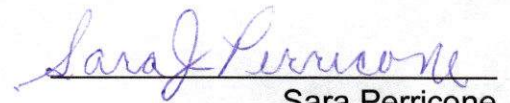

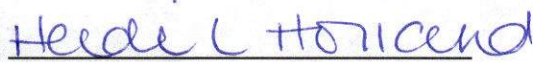
