4 OLD BUSINESS

- a) Mural Project
Presenter: Clark Hipolito

- b) Sculpture Trail Update
Presenter: Sara Perricone, Chair

Ms. Perricone provided an update regarding the Sculpture Trail. She stated all the plaques with QR codes have been or will be installed at some point during this week. Lights will also be installed on all sculptures. Atlas Starke has indicated an interest for a sculpture at Spring Branch. Ms. Perricone is meeting next week with them as well as our Sculpture Trail Consultant Jim Davis, to discuss possibility of their purchase or lease of a piece. At this time there was no update available regarding interest from Revival in a sculpture at this time. There was discussion regarding if there were a need for meeting in July. It was consensus not to hold a meeting in July. Ms. Perricone shared details regarding potential new member. Raven is an art teacher at Thanksgiving Elementary School and is very excited to be part of the board. She will make a great addition.

5 NEW BUSINESS

- a) Independence Day Fest
Presenter: Patrick Pierce, Economic Development Director

Mr. Pierce provided information regarding the Square to Square Independence Day Event which will be held on July 3, 2021. We will have numerous activities to include bike parade, rides, DJ, food trucks and an emergency vehicle parade at conclusion. There was discussion regarding chalk art to be included at the event. Mr. Pierce asked if the board was interested in heading up with event at the festival. There was lengthy discussion regarding the parameters of the vent. It was agreed that less structure for this type of event would be best. Ms. Perricone, Ms. Helmer and Ms. McLaurin stated they would be available to assist. Possible location of parking lot of Dr. Lloyd's office was discussed and Ms. Perricone stated she would reach out and determine if that location might be used. Mr. Pierce stated he would verify all the details regarding supplies with Amy Shearin, who is coordinating the event.

- b) Greenway Projects
Presenter: Scott Barnard, Parks & Rec. Director

Mr. Barnard was present and shared additional details regarding a continuous mural of 5.7 kilometers that is located in Canada. It was stated that Municipal Park to the Covered Bridge Road Greenway entrance via that greenway is roughly the same distance. It was stated that we have enough greenway in Clayton to beat the world record. Discussion was had out wanting to reach for that goal our first time out or if we extended it to get folks acclimated to the event on an annual basis. Mr. Hipolito suggested starting off small and building the project. Discussion continued and it was agreed that the new portion of the greenway would be the best location to start. It was stated this event could possibly be held November. Mr. Barnard stated the Parks & Recreation would love

to partner with PAAB to create a small scale event to include some food trucks, water bottles and tee shirts. Suggestion was made to start "planting seeds" at the Square to Square event. Mr. Barnard stated a Halloween event was scheduled to be held on October 30 and perhaps we tie this event into this annual event at Community Park or perhaps into Harvest Festival. It was stated that the Harvest Festival was scheduled to be held at the same time. Ms. Perricone stated she would discuss the possibility with Clayton Chamber to determine if they felt there would be value to include this as part of Harvest Festival. Ms. Murray stated she saw this as a stand-alone event. Mr. Barnard made suggestion that should the hayride have to move a couple of weeks later in the month of November or perhaps the weekend (October 23) prior to Halloween this event could be part of that celebration. Mr. Barnard stated he would check on any other events. There was brief discussion regarding the banners and concerns at the Community Center. We will work on this further.
