The winner of the People's Choice Awards is "Virginia Horse" which was located in Town Square. Artist Jonathan Bowling was the winner of the \$1,000 prize.

Ms. Beard stated the Sculpture Trail transition is happening, four of the new sculptures have already been installed. Summertime Blues has been installed in Horne Square, Life Cycle installed in the Roundabout, Big Orange Stack is at the Community Center and Muse 2 is now at Revival. Wings is scheduled to come in Thursday, May 23 and is planned to be installed at the corner of O'Neil and Main Street. Key Winds and High Rise both are scheduled to be installed on May 29th and Double Purple Whisper Bench to be installed May 28th. Ms. Beard stated she is interviewing the artists, shooting the videos and having the plaques made as the sculptures arrive. The brochure process will begin when all sculptures have been installed.

Ms. Beard stated she reached out to area communities and looked into their procedures and timelines. She stated this project is a lot to change out every year and there are other components such as brochures, videos, plaques, etc. She asked the board their thoughts on having the sculptures in place for a 2-year term instead of 1-year. It was discussed if the sculptures are here for 2 years, it will give the board more time to work on other projects. There was discussion on the possibility of the sculptures starting to fade or fall apart if they were on 2-year terms. It was suggested to have the contract state that it is the artist's responsibility to review the sculpture after a year and make any necessary repairs. It was also suggested to stagger the Sculpture Trail and the Greenway Project to fall on different years. There was a motion made to change the length of the Sculpture Trail from 1-year to 2-years.

Ms. Beard stated she would like some help on the Sculpture Trail Project, Ms. Murray stated she would be able to help. She would keep track of the different steps of the project and at the monthly meetings she can notify Ms. Beard of the next steps of the project.

She stated there may be some fish that need an extra coating before going out. She stated she will keep everyone posted on the installation.

Ms. Beard stated there are more of the smaller fish than any other size. The price suggestions for selling these fish are \$25, \$50 and \$75. Ms. Beard estimated there may be 3 of the larger fish that could be sold for \$75, the remaining would most likely be sold for \$25. It was suggested that the families of the art students should be able to reserve a fish

and buy it before anyone else could.

Mr. McFadden expressed his concern of creating the procedures, he stated he would like to contact Jane Roberts to get as much information as possible before beginning on the procedures.
