4 OLD BUSINESS

- a) Sculpture Trail Placements
Presenters: Stacy Beard, Public Information Officer and Sara Perricone, Board Chair
- Town Locations
 - Private Business Locations

Ms. Beard provided a PowerPoint showing the installation of some of the new sculptures. There was discussion regarding purchasing some of the favorite pieces. Concerns were voiced regarding possibility of artists losing interest in submitting additional artwork if their pieces were not considered for purchase. There was discussion regarding lighting

up the Oak Leaf Arch at Town Square as well as Dancer sculpture in Horne Square. Ms. Beard stated the Ark is located at the front of the Clayton Center and Brave New World is located at the library. Three Muses, Mask, Sea Glade and Virginia Horse will all be delivered next week.

Stacy stated she spoke with Paris Alexander who is the artist of Icarus Steele. She provided a sample agreement for private partnership with Revival 1869. There was discussion regarding location and ensuring there is public access to the sculpture. Ms. Perricone shared details of her discussion with Mayor McLeod. She stated the Mayor was under the impression that the alley way was property of the town. Mr. Stojic stated that was not true, the alley property was private property, owned by James Lipscomb. Mr. Stojic stated he would need to see if there was a value from a business perspective. There was also discussion regarding plaque that would be provided.

Ms. Perricone spoke about business sponsorship, which would allow smaller businesses to sponsor town pieces. There was discussion regarding town being able to accept sponsorships. Ms. Helmer stated she would reach out to City of Sanford to get additional information regarding their grant process. Ms. Beard stated she believed we needed to hold off for a bit to allow the gathering of additional sponsorship information from other municipalities. Board members will begin to gather this information and report back.

5 NEW BUSINESS

- a) Mosaic Garden Sculpture Garden
Presenter: Sara Perricone, Board Chair

Ms. Perricone requested the existing Mosaic Garden be included as part of the downtown sculpture trail/downtown art. There was some concern regarding the garden being on private property. Ms. Perricone stated they would just like to be included in the brochures and maps. Ms. Beard stated she would be happy to include their information on future materials.

- b) Sanford Trip - Murals
Presenter: Sara Perricone, Board Chair

Ms. Perricone and Ms. Helmer shared information about their recent trip to Sanford to view their murals. They stated many of the murals located on private downtown buildings are 3D. Ms. Perricone stated she would obtain a copy of the contract currently used by Sanford with the artists. There was discussion regarding art on buildings versus signage on buildings. Ms. McLaurin stated she would be very happy to see murals that depicted "old Clayton" on buildings. Ms. Perricone will gather additional information.

There was discussion regarding student art project. Ms. Helmer stated she knew of an Eagle Scout who would be perfect for this project. He is an artist and would be very excited to assist. She stated she would reach out and follow up at next meeting.

Ms. Beard stated that she had reached out to Jane Roberts. She was unable to attend this meeting but does have some additional ideas for student art projects. She will stay in contact.

Sara briefly shared information about a new idea of displaying pianos around town, they would be available to the public to play, explore and enjoy. These piano(s) could be painted and/or decorated, it has not been determined yet who will paint them. Sara mentioned Horne Square was one location to possibly put a piano. There was discussion on what to do when bad weather was predicted, Sara mentioned creating a team of weather monitors that would be responsible for covering up the piano when bad weather was expected. It was agreed that this was a good idea and should be discussed at future meetings.
