a. Sculpture Trail Location Selection

The analysis from the engineering consultant is in and a spreadsheet with all the sculptures and locations they would fit in was provided to all board members. There was discussion about the location of the sculptures.

The Town is in discussion on whether to purchase Everlasting Arms, which is located in Town Square. After much discussion, the locations are as follows:

(Location 1) Town Square, Fay St. - *Everlasting Arms - if it isn't bought B28 Low Poly Hearts*

b. Field of Flowers Update

Board Member Smallwood brought samples of the flowers to share with the board. She stated she has 13 mid-size ones, 20 small ones, and 4 large ones completed. Late Night Fabricators welded the flowers together. There was discussion on where to place the flowers throughout the Town and how many days it would take to install, once all the flowers are completed. There was discussion on where to store the flowers until the project was ready to be revealed.

Julia Curran, Chair of the Library Advisory Board, was present to discuss the possibility of installing a mural at the library following completion of the renovation. Board Member Parton stated she would contact the art teacher to gauge interest. The Board further discussed involving the Downtown Development Advisory Board (DDA) to make the project a collaborative effort among the three advisory boards. Ms. Curran also expressed interest in involving the Friends of the Library. Board Chair Martin stated he would compile information and forward it to Ms. Curran.
