- a) Parks and Recreation Master Plan
Presenter: Scott Barnard, Parks and Recreation Director

A meeting with Sage Design, the Parks and Recreation Master Plan consultant, is scheduled to present findings to the Advisory Board and note any feedback.

- b) Municipal Park Shade Structure

The installation of the Municipal Park shade structure is almost complete. Poles have been set in concrete, inspections have passed, the shade is being custom cut and is scheduled to be installed this week.

- c) Clayton Community Park Project

The Community Park construction project is underway with much dirt moving. Initial construction will be the sports courts to be located at the tree line and then work will move outward from there. All is on schedule and the weather has been favorable. Mr. Barnard shared that all seem happy with the progress thus far.
