3 OLD BUSINESS

- a) COVID-19 May Changes
Presenter: Scott Barnard, Clayton Parks and Recreation Director

Mr. Barnard stated there have been changes indoors and outdoors as COVID numbers decrease. The department has dropped mask requirements in youth athletics, but will remain wearing them indoors. Most indoor programs are back including pottery, art, and fitness. Staff is still encouraged to wear masks, and required to take daily temperature checks.

- b) Summer Camp 2021

Mr. Barnard stated Camp Clayton registration was open, numbers are not close to previous years but they do seem to be comparable to other camps in the area. Everyone is struggling due to parents realizing they can stay home as well as continued COVID fears. We will be hosting camp at 2 different locations this year, the middle school will be home to older groups, and younger groups will remain at the community center. Lots of organizations are struggling to find staff, luckily we are not having that issue. Regardless, we are looking forward to a fun summer for campers!

4 NEW BUSINESS

- a) Bond Project Discussion
Presenter: Scott Barnard, Clayton Parks and Recreation Director

Mr. Barnard stated we are looking to present council with bond recommendations this month. Mr. Barnard encouraged all to speak up and voice their opinions. It would be great if when projects were recommended to council to have the support of the board at the council meetings. The list of projects would start of ECCP including 2 artificial turf fields, lighting, paving at least half of the parking lot, and improving the entrance area. This total would cost about 4.5 million dollars. The second set of work to be done would be at Municipal Park. Municipal Park renovations would be major and a huge asset to Downtown Clayton. This work would include a splash pad, walking trail, band shell and restrooms, natural turf area, shelter, and updated sports courts. This work will cost about 4.5 million dollars. Other work would be at CCP which would include tennis court updates, lights, and additional courts at Clayton Community Center. Once all project recommendations have been presented and approved by council, work will begin with meeting with contractors and crews.

It was shared that we recently rolled out new programs, partnerships with Snapology of Wendell, specialty camps. New fitness class will be starting up, and everyone is preparing for summer camps and programs.
